Dear UCSB students,

We wanted to remind you all of the resources available to UCSB community, particularly resources to undocumented students. There has been an increase in coverage on undocumented families' detentions. This coverage and policy adds to stress and struggles that immigrant communities are currently facing under this administration. We offer our support and affirm our commitment to all of the undocumented members of our UCSB community.

Additionally, we recently learned that there was an immigration raid in Goleta, which was allegedly part of a three day operation across the region. According to news reports, Immigration and Customs Enforcement (ICE) apprehended 22 people in Santa Barbara County, including 5 in Goleta. There are resources available in case you, or someone you know, need(s) assistance:

If you were affected by this raid or need emergency assistance, please contact Diana Valdivia at (805) 708-4739. She will then work with you, and the immigration attorneys that are assigned to UCSB. These attorneys are Vivek Mittal and Ron Perry, who are part of the <u>UC Immigrant Legal Services Center</u>. Ron is part of the AS legal services and his office is at the AS Pardall Center in Isla Vista. He is available for drop-ins and appointments.

Know Your Rights, in case you encounter an ICE officer. You have the right to remain silent; you can choose to exercise that right, especially if an officer is asking you questions about anything including your immigration status. You have the right to refuse consent for a search; if an ICE officer is asking to search your bag, vehicle or residence, you can refuse consent. You also have the right to ask for an attorney who can then speak on your behalf to ICE, if necessary.
